## Loan Agreement Terms and Conditions

1. Oak Tree Animals' Charity or their representative has the right to visit and inspect the equine described at any time.
2. Oak Tree Animals' Charity has the right to remove the equine at any time without notice should a representative deem it to be in the best interests of either the equine or the Charity.
3. Oak Tree Animals' Charity may remove the equine at any time without notice if the terms of the Loan Agreement are broken.

### Rehomer

4. The Rehomer will not neglect or ill-treat the acquired equine.
5. The Rehomer will provide appropriate shelter, nutrition, access to clean water, veterinary/medical care. The equines' standard of living will always be a priority.
6. The Rehomer will give Oak Tree Animals' Charity at least two weeks' notice in writing of any intended change in address at which the equine is to be kept and will refrain from moving the equine until authorisation has been given.
7. Rehomers are not permitted to take the equine permanently out of the UK.
8. The Rehomer will be responsible for all costs relating to the equine for the duration of the loan.
9. The Rehomer will be responsible for all transport costs and arrangements including the collection and return of the equine to Oak Tree Animals' Charity.
10. The Rehomer shall indemnify Oak Tree Animals' Charity and its servants against any claim for injury or damage caused by the equine and will be responsible for providing a minimum of third party insurance.
11. The Rehomer has agreed to take the equine on loan and has taken into consideration all known problems related to the equine as listed on this agreement.
12. In the event of an equine being returned to Oak Tree Animals' Charity the Rehomer will return all paperwork relating to that animal, including its passport. If the passport is lost or damaged, it will be replaced at the rehomer's own expense.
13. In the event that the Rehomer wishes to return the equine, at least four weeks written notice shall be given to Oak Tree Animals Charity.
14. In the event of an equine being returned from loan, the Rehomer will lose all contact with the equine.

## **Equine**

15. The equine will always remain the property of Oak Tree Animal's Charity. The equine will not be sold on or given away by the Rehomer.

16. The Rehomer will consult a qualified veterinary surgeon in every case of sickness, accident, disability or disease; strictly follow their advice and record details on the page provided. ALL veterinary fees so incurred will be the responsibility of the Rehomer.

17. An appropriate worming programme is followed, the equine is wormed as required and the details recorded on the page provided.

18. The equine's vaccinations for flu and tetanus are kept up-to-date and the passport correctly amended and signed by the administering veterinary surgeon.

19. The equine's feet are trimmed and/or shod as required by a qualified farrier registered with the Farrier's Registration Council and the details recorded on the page provided.

20. In the event that a veterinary surgeon recommends euthanasia, or in an emergency, the equine shall be humanely destroyed either by a veterinary surgeon or a licensed knacker. The Rehomer shall be responsible for completing a Notification of Death/Euthanasia form and returning it to Oak Tree Animals' Charity within 5 working days of the animal's death along with the passport. All costs incurred are the responsibility of the Rehomer.

21. The equine will only be used for the purpose stated on the agreement.

22. The equine will not be used for breeding.

23. The equine will not be used for any commercial purpose (e.g. riding lessons, working livery, hire, etc.) or otherwise let out of the Rehomers possession without Oak Tree Animals' Charity's written consent.

24. Oak Tree Animals' Charity does not give any warranty as to the fitness of the equine for any purpose.
