Loan Agreement Terms and Conditions

Please read through the terms and conditions carefully before signing.

1.0 Oak Tree Animals' Charity

- 1.1. Oak Tree Animals' Charity or their representative has the right to visit and inspect the equine described at any time.
- 1.2. Oak Tree Animals' Charity reserves the right to contact the veterinary practise, farrier, dentist or any other professional equine service the loan home may use to retrieve information.
- 1.3. Oak Tree Animals' Charity has the right to remove the equine at any time without notice should a representative deem it to be in the best interests of either the equine or the Charity.
- 1.4. Oak Tree Animals' Charity may remove the equine at any time without notice if the terms of the Loan Agreement are broken.
- 1.5. Oak Tree Animals' Charity will carry out home visits which is usually started at 1 month then 6 monthly and then annually however, is subject to change.

2. Rehomer

- 2.1. The Rehomer shall not neglect or ill-treat the acquired equine.
- 2.2. The Rehomer shall provide appropriate shelter, nutrition, access to clean water and veterinary/medical care. The equine's standard of living shall always be a priority.
- 2.3. The Rehomer shall give Oak Tree Animals' Charity at least two weeks' notice in writing of any intended change in address at which the equine is to be kept and shall refrain from moving the equine until authorisation has been given.
- 2.4. Rehomers are not permitted to take the equine permanently out of the UK.
- 2.5. The Rehomer shall be responsible for all costs relating to the equine for the duration of the loan.
- 2.6. The Rehomer shall be responsible for all transport costs and arrangements including the collection and return of the equine to Oak Tree Animals' Charity.
- 2.7. The Rehomer shall indemnify Oak Tree Animals' Charity and its servants against any claim for injury or damage caused by the equine and shall be responsible for providing a minimum of third party insurance.
- 2.8. The Rehomer has agreed to take the equine on loan and has taken into consideration all known problems related to the equine as listed on this agreement.
- 2.9. In the event of an equine being returned to Oak Tree Animals' Charity, the Rehomer shall return all paperwork relating to that animal, including its passport. If the passport is lost or damaged, it shall be replaced at the Rehomer's own expense.
- 2.10. In the event of the equine being returned to Oak Tree Animals' Charity, the horse will need a strangles test prior to return, which will be paid for by the rehomer.

- 2.11. In the event that the Rehomer wishes to return the equine, at least four weeks written notice shall be given to Oak Tree Animals Charity.
- 2.12. In the event of the equine being returned from loan, the Rehomer shall lose all contact with the equine.

3. Equine

- 3.1. The equine shall always remain the property of Oak Tree Animal's Charity. The equine shall not be sold on or given away by the Rehomer.
- 3.2. The Rehomer shall consult a qualified veterinary surgeon in every case of sickness, accident, disability or disease; strictly follow their advice. ALL veterinary fees so incurred shall be the responsibility of the Rehomer.
- 3.3. An appropriate worming programme is followed as recommended by Oak Tree staff or the rehomer's veterinary team. The equine must only be wormed when required.
- 3.4. The equine's vaccinations for 'flu and tetanus are kept up-to-date and the passport correctly amended and signed by the administering veterinary surgeon.
- 3.5. The equine must have, annual dental treatment unless advised by a vet to have more regular visits e.g. 6 month checks.
- 3.6. The equine's feet shall be trimmed and/or shod as necessary by a qualified farrier registered with the Farrier's Registration Council.
- 3.7. If ridden or driven, the equine must be fitted with correctly fitting tack. All saddles must be fitted using a qualified saddle fitter.
- 3.8. Should a veterinary surgeon recommend euthanasia, or in the event of an emergency, the equine shall be humanely destroyed either by a veterinary surgeon or a licensed knacker. The Rehomer shall be responsible for completing a Notification of Death/Euthanasia form and returning it to Oak Tree Animals' Charity within 5 working days of the animal's death along with the passport. All costs incurred are the responsibility of the Rehomer.
- 3.9. The equine shall only be used for the purpose stated on the agreement.
- 3.10. The equine shall not be used for breeding.
- 3.11. The equine shall not be let out of the Rehomer's possession without Oak Tree Animals' Charity written consent.
- 3.12. Oak Tree Animals' Charity does not give any warranty as to the fitness of the equine for any purpose.
