 - Individual Giving working with the Individual Giving and Events Fundraiser to deliver campaigns, appeals, and supporter journeys.
 - Events planning, coordinating, and delivering charity-led and third-party events alongside the Individual Giving and Events Fundraiser.
 - Grants and Trusts preparing and submitting applications, monitoring progress, and reporting to funders.
- Work collaboratively with the other Fundraising Coordinator and the Individual Giving and Events Fundraiser to ensure strong coverage across all fundraising areas.
- Build and maintain strong relationships with donors, supporters, schools, community groups, businesses, and funders.
- Provide excellent supporter stewardship to maximise long-term engagement.
